4. Public Comment

- **Resident, William Aucoin:** mentioned wanting to have soccer goals installed at OCP. His kids play competitive soccer and it would be a nice addition to the neighborhood. He doesn't envision full-sized goals; junior sized goals would suffice.
- **Dr. Ken:** An OC resident, with his daughter present, said that the neighborhood is aging and with \$10,000 listed under capital improvement in our budget, soccer goals would be a good investment and raise property values.
- Mark: Another resident, also came in support of soccer goals. He said that just about every kid has played soccer at one time or another. Nets are well worth the risk (cost). Trustee Carelli, asked what sized goals would work for kids of all ages. The answer was not immediately forthcoming. Dr. Ken asked why there was such a concern about security in a locked park. The Trustee explain that vandalism occurs at that park.
- Rachel Pullaro & Brandon Thames also spoke in support of having soccer goals at OCP.
- In all, nearly fifteen residents showed up in support of soccer goals at OCP.
- **Trustee Costa:** Played soccer for 30 years, indoor and outdoor and Coached for six years. **The Trustee** said that full sized goals were not necessary. Junior sized goals, six by twelve would suffice.
- **Brian Hughes:** Trees were taken down in his area of OC. If a Palm Tree were installed in the common area, it would look great and fill in the space nicely.
- **Brian Hughes:** The resident also suggested that we have an off-duty officer to police traffic during i9 Sports. Parking is terrible as is the traffic on McFarland. The residents are paying for the amenities, we should be able to use them.

Ryan Maas — Treasurer Matters

• **Trustee Maas:** The census survey has been completed. The proposed budget had an incorrect date. It has been corrected. The revenue line item has been increased to account for payments by the softball teams. The budget has increased slightly since last year. However, our budget will likely not go over projections.

Mark Snellgrove — President's Agenda

- **Trustee Snellgrove:** A small section of the parking lot at White Sands Beach had to be dug up because of water damage.
- Trustee Rasemont, speaking with commanding gravitas, said she would look into the issue.

Vice President Mickey Jaap — Tennis & Recreation Center Chair

• Trustee Jaap: Not Present.

Michael Carelli — Original Carrollwood Park

- **Trustee Carelli**: Residents had previously suggested that the gates at OCP were in poor condition. **The Trustee**, having thoroughly inspected the gates, said that they were fine. **The Trustee** also inspected the benches and said they are not in good condition and in fact they were dangerous. The benches have been replaced with benches made of aluminum and recycled plastic. They are a forest green color.
- Trustee Carelli: The softball field had sprinklers installed. Previously, we were watering with a

hose from the dog park. Now the sprinklers are permanent and on a timer.

- **Trustee Carelli:** Brought up the idea of installing permanent soccer goals at OCP with Anthony Vetrano of i9 Sports. Mr. Vetrano was not receptive to the issue.
- **Trustee Carelli:** Told **Trustee Costa** (who previously wrote and administered the agreements with i9 Sports) that Mr. Vetrano said that **He** and **Trustee Costa** had a "Gentleman's Agreement" regarding i9 Sports Clinics. (These are clinics are held at a different time than the i9 regular season). **Trustee Costa** said that the statement was absolutely untrue. Every i9 season and every clinic had a written agreement. **Trustee Costa** said he could easily produce all of the i9 agreements including those for the clinics. **Trustee Carelli** said it would not be necessary, but that i9 Sports had not been payed their bills, and thus, have broken their agreement.
- **The Board:** In general discussion, **The Board**, overwhelmingly agreed, that i9 Sports—having neither paid their bills nor followed the rules stipulated in the agreement has worn out their welcome. Their contract will not be renewed after their current season. The agreement was unanimous.
- **Payson:** In following up on a previous visit regarding vending machines at our local parks, Payson offered **The Board** a new proposal. He would give the neighborhood 25% of all profits.
- **Trustee Carelli,** recapped what was said at previous meetings to bring absentee members up to date on the vending machine proposal. **Trustee Snellgrove** asked each member of **The Board** to comment.
- **Resident, Paul Siddall:** Equated what Payson wants to do to what is done at public schools and other public facilities.
- **Trustee Carelli:** Asked the board, "Do we want vending machines?" **Trustee Lais**, said yes, but that we should bid them out. In an informal discussion, a majority of **The Board** said no, in regard to placing vending machines at our local parks. All of **The Board** members marveled at Payson's determination and professionalism in presenting his case.
- **Trustee Carelli:** John Probst called **The Trustee** about wires having been dug up at OCP. It turned out to be a non-issue.

Kevin Shidler — White Sands Beach Chair

- **Trustee Shidler**: New grills have been ordered for the grill at WSB. **The Trustee** will have a customized piece of aluminum made for drainage.
- **Trustee Shilder**: Explained that there was vandalism at OCP. Someone took a sledge-hammer to the sidewalk. **Trustee Rasemont** wisely suggested video monitors and said that if the amenities look like garbage, no one will want to use them. **Trustee Shidler**, suggested that if we spend money at the beach, we should spend our money wisely on items we need.

David O'Donnell — Scotty Cooper Park Chair

• **Trustee O'Donnell:** The CRD Office Manager sent **The Trustee** an invoice for repairs of a water leak at Scotty Cooper Park. **The Trustee** questioned whether it should be paid out of his budget or a different budget. The bill was for \$250. However, the problem is not resolved and there will be more expenses. **Trustee Snellgove** suggested additional funds can be taken out of the budget for Grounds. **Trustee Lais**, said he was fine absorbing that cost. **Trustee O'Donnell** was incredibly thankful; and why wouldn't he be.

Bill Lais — Grounds Chair

- **Trustee Lais:** Stated that the SCP water leak caused other issues. **The Trustee** stated that Greenview, can do the irrigation repairs. They are supposed to repair anything they damage. But we can also ask them to work on other irrigation issues.
- **Trustee Lais:** The Bank of America island gets no irrigation and it is the island leading into Original Carrollwood (if the foliage dies it will be unsightly). Also, the ligustrum along the island might be stressed for lack of water and could easily be infected by disease. **The Trustee** also mentioned that one diseased palm tree in the neighborhood could infect many other palms. **The Trustee** suggested that we change our Canary Date Palms with a different, perhaps, hardier palm.
- **Trustee Lais:** Asked how **The Board** feels about cleaning up the walls of foliage (in the areas between Phoenix Circle and McFarland Drive). **Trustee Shidler** said that according to the EPA, we can only clean up a distance of six feet on either side of the wall.

Jessica Rasemont — Community Development

- **Trustee Rasemont**: Commanding the floor with an effervescent *je ne sais quoi* seldom heard in these chambers, **The Trustee** updated The Board on the wall saga at White Sands Beach, saying that it wasn't done yet, but would be completed this week.
- The bid from Chuck Kim to pressure wash and paint the wall at WSB was \$3,600. **The Trustee** will seek other bids as this price seem excessive.
- **Trustee Rasemont**: Asked **Trustee O'Donnell** if he found paperwork for the original dock installation. **The Trustee** had not found the paperwork.

4. Public Comment

- **Resident Shelley Stuart** asked that OCP be reserved for Woofstock 2017 on Saturday, October 21st.
- Ms. Stuart also asked that the Board look into adjusting or moving the OCP Service Gate to make additional parking. **Trustee Shidler** said he would be opposed to having additional parking at OCP. The OCP service gate is directly across from Phoenix Circle and it would create issues for residents. A resident from the audience agreed with **Mrs. Stewart** and suggested that with older residents, perhaps additional parking would be a good idea. Another resident suggested that if we did add more parking we would have more users of the park.
- **Resident Billy Aucoin, 10914 Carrollwood Drive** stated there are a lot of kids who love soccer and play soccer. **Mr. Aucoin** would like to see if we would consider putting soccer goals in the park. **Trustee Costa** mentioned the vandalism that has occurred in OCP and that the soccer goals might be stolen or destroyed. Another resident mentioned that Recreation Center in new Carrollwood secures their goals with chains and locks. **Trustee Carelli** mentioned speaking with i9 about a partnership, still, the goals would have to be anchored.
- **Payson (an elementary school student):** revisited the Board regarding vending machine concerns. Payson discussed and addressed many of the Board's concerns regarding vending machines. Payson's father also addressed the Board regarding issues brought up by the Board Attorney.

Ryan Maas — Treasurer Matters

• **Trustee Maas:** Working on the proposed budget. Will have the final proposed budget in May. The new fiscal year begins October 1st.

Mark Snellgrove — President's Agenda

- **Trustee Snellgrove:** Per code, the Board is required to have two pumps for the lift station. The repair of the lift station pump across from the Rec Center is \$2,290. A new pump would be in excess of \$6,000.
- Motion from **Trustee Rasemont**: To approve repairing the lift station pump at the Rec Center for the cost of \$2,290.00
- Seconded by Trustee Carelli
- Vote: 6 in favor, 0 against
- **Trustee Snellgrove:** Regarding Payson's Vending Machines: because we are a State Entity, there are numerous red flags in regard to putting a vending machine at any of the parks. **Trustee Carelli** commended Payson for his presentation, but said he would vote against it for numerous reasons, including the legal issue of a resident making money on vending machine that sits on public property. Other issues include: securing it, powering it, servicing it, stocking it, etc. **Trustee Shidler** added that if one resident is allowed to put up a vending machine and personally make a profit, others will want to do the same, and how could we argue against it. Payson's mother added that it is a unique opportunity that the Board should consider. The opportunity to run the vending machine could be put up publicly for bid. **Trustee Shilder** suggested that because we are a State Entity, numerous legal issues would govern how we bid and run the "vending" business. **Trustee Maas**, told Payson that persistence pays off and though this may not pass now, it may pass at some time in the future.
- **Board Discussion:** In a general board discussion regarding vending machines, the tentative vote would have been 50/50, keeping in mind that only six members were present. **Trustee Costa** reminded Payson that if he came back when all the members were present, the vote might go a different way.
- **Trustee Snellgrove:** announced that the Board required a public hearing notice announcing the proposed budget, and that the Secretary, **Trustee Costa**, would place the notice in a Hillsborough County

Newspaper.

- Motion from **Trustee Maas:** To authorize **Trusee Costa** to place a public hearing notice in Hillsborough County newsaper.
- Seconded by Trustee Carelli

if there were any guarantees. **Trustee Costa** stated, in an amazing eloquent manner, that the language in the agreement was grammatically incorrect and confusing, especially in regard to the discount.

- Motion from **Trustee Costa:** To authorize **Trustee Rasemont** to hire Jerry Muncey's Lakefront Beach Cleaning to remove the eel grass at WSB for a total cost of \$3,600, contingent on the contract stipulating a specific and define area of work to be determined by the **Trustee**, and that the weeds be taken out by the root.

- **Trustee Rasemont**: Had a roofing company come out to WSB to look at the roof. The **Trustee** said that the roofer would not cut back the compromised beams. The work would require a general contractor.

LOCATION: Carrollwood Recreation District - 3515 McFarland Rd. - Tampa, FL 33618

CONDITIONS: Resurface 4 tennis courts with a fiberglass mesh overlay and a 5 coat system in total.

1. Florida Courts will first pressure wash any mildew or dirt off the courts to provide a proper base for adhesion of resurfacing materials.

2. Florida Courts will also flood the courts and check for low areas, then will correct, as best as possible, those areas where standing water covers 1/8" in depth (thickness of a nickel) after the surface has been able to dry under normal conditions for 1 hour.

3. Florida Courts will fill any cracks wider than 1/8" with Acrylic Patch Binder cement mix. We will then apply 1 first initial coat of Acrylic Resurfacer, fortified with sand, to cover the numerous wide crack repairs and to fill in the smaller cracks – this will then also provide a more suitable surface for the following fiberglass mesh overlay.

 Florida Courts will install a fiberglass mesh overlay covering the entire 4 court surface. This will help to keep the numerous cracks from reappearing.

5. Florida courts will resurface the existing 4 court area using Sport Master

specifications and materials with a 4 coat color system, in the colors chosen by the client, (no additional charge for two-tone). 2 coats of Acrylic Resurfacer, fortified with sand, will first be applied to prepare the court surface for the following color coats. This will be followed by the application of 2 coats of Color Concentrate, fortified with sand, to provide uniformity & depth of color.

6. Florida Courts will re-stripe all game lines with 1 coat of Stripe Right Primer and 1 coat of heavy bodied Textured T/C White Line Paint (this will make for sharp edged clean lines). Florida Courts will re-paint tennis net posts.

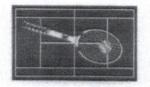

Welch Tennis Courts, Inc., (hereinafter referred to as the "Contractor") proposes to furnish the labor, materials, equipment, and services necessary to resurface the following: two (2) "All Weather" Tennis Courts at: the Carrolwood Recreation Center in Tampa, Florida. In accordance with, and subject to, the terms, conditions and specifications set forth below, the construction work is referred to in this proposal as the "Project."

1. COURT RESURFACING: The Contractor shall resurface two (2) all weather tennis courts, each court measuring approximately 60 feet by 120 feet.

- COURT PREPARATION: Contractor shall remove loose dirt, mildew, oil spots and foreign matter from courts.
- VEGETATION REMOVAL: Remove grass or other vegetation growing on the courts surface, sterilize and patch with acrylic patch binder as necessary.
