4. Public Comment

- **Trustee Snellgrove** presented a brief history of the CRD Board and Original Carrollwood, then informed visitors that Chamberlain High School principal, Jake Russell would speak.
- Resident Cory Stewart would like to have his wedding at White Sands beach on October 7th 2018 at 4:00 p.m. He would like it to be part of his family history. He will hire a company to pressure wash the dock and the concrete and to clean the sand at the beach. Trustee Snellgrove told Mr. Stewart that the board would address the wedding when we discussed White Sands Beach business.

Presentation — Mr. Jake Russell, Principal of Chamberlain High School, came from Sickles High School. Principal Russell was appointed in April of 2017 and took over as principal in June. He knows that the school needs work and he has a plan to address the schools' issues. Chamberlain School Stats include: 1,600 kids, 85% on free or reduced lunch. Challenges included, non-English speaking students. Proficiency in reading is low. Working with Adams, Sligh, Memorial and Van Buren middle schools to improve literacy. Community involvement is lacking.

Dr. Jazrick Haggins, AP of Curriculum at Chamberlain, was also present. He outlined two major educational goals, including, student performance and instructional priorities. Data has demonstrated that students are lacking literacy skills. Instructional priorities: Reading with purpose. Literacy, reading and writing is now a priority in all areas of study. There is a new focus on instructing teachers in every subject on lesson and curriculum planning. There is also a program to provide Positive Behavioral Support and rewards for students. It has proven beneficial to show struggling teachers how a high-performance classroom functions. The purpose is to both teach and inspire.

Chamberlain has been awarded an AP Capstone designation. Students who graduate with AP Capstone on their diploma, stand out during the college admission process. Chamberlain will also have a Health and Science Academy.

- Motion activated lights have been installed at WSB. The will stay on for a short period of time. It would change behavior (of those trespassing after hours).
- The roof over the pavilion at WSB was never properly sealed. Water has damaged the endcaps. A number of contractors looked at the work and did not want the job. Complete Maintenance, Inc. has provided an estimate of \$18,950.00 to repair. **Trustee Snellgrove** has said that the only place we have money is Community Development. As required, three companies were solicited.
 - Motion from Trustee Rasemont to: hire Complete Maintenance, Inc., to repair the pavilion at White Sands Beach if the owner can provide a valid General Contractor's license.

- **Resident:** Missy Siddall, who has just gotten a dog, would like to have additional parking at Original Carrollwood Park. **Trustee Carelli** explained that a parking lot at OCP would cause other issues, such as, parking problems and dangerous overflow onto Orange Grove Drive. He also does not want the softball teams to park there. **Trustee Shidler,** also voiced his concern about having a parking lot, because the lot would be directly across from his street, Phoenix Circle.
- Trustee Siddall: would like John Probst to repair lights at OCP.

Kevin Shidler — White Sands Beach Chair:

• Trustee Shidler: The wedding at WSB is not a good idea, because we cannot close the beach to residents. Mr. Stewart said he did not expect that and did not worry about residents being present during the ceremony. Trustee Jaap, said that 75 people exceeds the number of people allowed at a private party. Trustee Shidler proposed an option: Mr. Stewart could rent WSB and have 25 non-Original Carrollwood Residents at his party. Any OC residents who attended would not count toward that number. So, it is possible of have more people than 25. The Trustee went on to say that Mr. Stewart could have the wedding if he rented the beach and followed all the rules of WSB. Trustee Shidler will work with Mr. Stewart after he books the beach through proper channels.

David O'Donnell — Scotty Cooper Park Chair

- **Trustee O'Donnell:** There is still and issue with paying the roofer at SCP. Otherwise, the park looks good now that landscaping is done. The **Trustee** is trying to get closure on the roof issue.
- Trustee Snellgrove: The sprinklers from SCP to Dale Mabry are now working.

Paul Siddall — Grounds Chair

- Will get with Greenview and see what sprinklers need to be fixed on the islands.
- Residents are complaining about the trees on Lake Carroll Way. The **Trustee** also proposes putting an OC sign in the median.

Jessica Rasemont — Community Development

• Trustee Carelli said that Trustee Rasement has been looking into installing a volleyball court, which needs to be 40' by 80' by 18 inches deep. That's 24 yards of sands. The cost would be approximately \$18,000.00. In speaking to suppliers, the sand alone would be \$11,000. The board will not move forward with the volleyball court.

- **Trustee Jaap** found CRD notes, old enough to be destroyed, but he thought that someone might be interested in looking at them.
- **Trustee Jaap** reiterated his desired to resign from the board effective February 12, 2018 after the close of business. He also mentioned having read the bylaws. There is no specific procedure for appointing new members.
