4. Budget Presentation by Treasurer Mark Georgiades

- **Trustee Georgiades** briefly reviewed points of interest on the 2020-2021 annual budget, stating that, "It is our goal is to meet a \$620,017.00 budget."

Mark Georgiades — Treasurer Matters:

• Trustee Georgiades: No new business.

Mark Snellgrove – President Matters:

- Trustee Snellgrove:
 - Discussed future dates for <u>Off-Duty Deputies</u> at White Sands Beach. Trustee Snellgrove deferred to Trustee Shidler regarding <u>Off-Duty Deputies</u>. The dates and times suggested included: July 4th and 5th, 1-7 p.m. The Trustee also added that there would not be a neighborhood parade or ski show this year as per the CCA.
 - Personnel Matters: Maintenance Position Interviews
 - Trustee Snellgrove: explained, in regard to the wedding of Laura Allegri, who was promised use of the rec center for her wedding, that when asked about use of the room, he was forced to abide by Hillsborough County Guidelines. According to Shelley Steward, the wedding is now taking place at the Carrollwood Cultural Center. Trustee Carelli cited the Governor's press released stating that venues can be opened at 50 percent capacity. Trustee Shidler, warned that we could not guarantee the room, if the Governor and/or Hillsborough County change their protocols regarding Covid-19 social distancing. Trustee Siddall explained that he works for the state, and he advises that we should follow state and then county guidelines, which at this point, is 50 percent. Trustee Siddall explained that the board did not make decisions out of malice. We should apologize to Laura and establish a new policy moving forward. Our contract for rentals should state that rentals are subject to change based on the state's covid occupancy regulations.
 - **Trustee Snellgrove:** there are two candidates interested in the Board maintenance position.
 - 1. **Steve Bourland:** stated that he realized that spending time on this part time job would take away from his regular job but wanted to address an issue at White Sands Beach (which **Trustee Shidler** addressed). **Trustee Shidler** stated that seaweed at the WSB is an on-going issue. **The Trustee**, using his phone, showed photos of a portable backhoe, because doing the job by hand is far too much for one individual to do in the allotted time. **The Trustee** explained the 2 ½ hour process: the seaweed is raked, loaded with pitchfork onto a wheelbarrow, and carted to a vehicle for disposal because it starts to smell. The next day, the seaweed is back. The job is overwhelming. Steve cannot fully commit to the job. Steve has a lawncare business but has cut down is accounts significantly.
 - 2. Gary Greene: Gary stated that he and his wife have lived in Original Carrollwood for more than 12 years. He is proud of the community. He is approaching retirement (and will retire at the end of the year). He has his wife's A-OKAY to get the job. He is mechanically inclined. He said, "This job will fit my lifestyle." He currently gets off of work at 2:00 p.m., and can be here by 2:45 or 3:00 p.m.

3. Trustee Snellgrove: Suggested that the Board offer the job to Gary Greene, but also use Steve, whenever necessary. **Trustee Shidler** stated that Steve did excellent work helping at WSB.

Suzan Giunta — Vice President & Grounds

• Trustee Giunta: Not Present

Paul Siddall — Recreation Center & Tennis

- **Trustee Siddall:** has tried three times to get the tennis company back to make good on the warranty and fix the courts. The company has not responded. **Trustee Carelli** will call the company.
- **Trustee Siddall:** What are my responsibilities as Rec Center/Tennis Chair. **Trustee Snellgrove** provided a brief of his duties as they have typically been conducted.

Michael Carelli — Original Carrollwood Park:

• **Trustee Carelli**: has been getting calls about using the softball field and soccer field, however, the park is not officially open. **The Trustee** has asked Janet to set up a sign-up sheet for residents. Residents do not have to pay, but will be assigned a time-slot.

Three employees from the lawn maintenance service ASI attended the meeting. The group of men came to discuss confusion over "alleged" charges to Original Carrollwood

Eric, of ASI: stated that there have not been any repairs done on the irrigation since • January. The gentleman detailed issues that have arisen over the past few months. The only money billed was the \$518.00 in January. The other issues are estimates for repairs not yet approved. Trustee Snellgrove explained that the cost to the Board is nearly \$800 per month (nearly \$9,600 per year) to check the sprinkler system. The **Trustee** questioned Eric on how the Board is supposed to know what is actually being done and when. Trustee Snellgrove also asked about modifying the contract. Eric said that they would be happy to modify the contract. **The Trustee** asked about the outstanding estimates for repairs. Eric stated that the two estimates amount to: \$3,402.25. Trustee Georgiades asked about treating dollar weed. Joe (from ASI) explained how it is done. Trustee Shidler asked if they (ASI) are in fact breaking the sprinkler heads and other equipment as part of their regular maintenance. Eric said that the equipment is made of plastic. The stuff breaks easily. Joe added that if they break something, they make note of it on their report. Joe also said that the heads are on flex pipes which typically give and don't break. Eric added that when the plastic risers wear out, they stay up and are more prone to damage. **Trustee Snellgrove** asked why SCP is in such bad shape. Eric explained that SCP has expensive equipment, specifically the valves and rotors. ASI Phone Number: 407-338-9719. Trustee Snellgrove explained that we have seen a drop-in revenue like any other business. Joe added that ASI could inspect every other month. **Trustee Snellgrove** explained that there have been complaints, including: the dog park not being mowed, and one area where a worker was caught on camera not fertilizing an area that was paid for under contract. **Trustee Siddall**, asked that when mowing, to try not to hit the fence in the dog park. **Resident Jack Griffie** asked who is in charge of adjusting the water supply. Eric stated that they check those levels continually based on the weather and the need.

- **Trustee Georgiades**: suggested that we do not need a monthly inspection at \$800 per month.
- **Trustee Carelli:** suggested that we create a specific schedule, not go on a regimented every other month schedule. **The Trustee** suggested: a modified schedule, a lower inspection rate and a lower hourly repair rate.
- **Trustee Price:** Suggested we negotiate on price. **The Trustee** asked Steve to comment. Steve suggested a schedule and added that we can always call to discuss hot spots. Steve suggested a schedule of six times per year. Steve suggested that the cost for the valves was not out of the ordinary.

Kevin Shidler — White Sands Beach:

- **Trustee Shidler:** Shidler has fielded numerous calls about crowds at Original Carrollwood Park, teams are showing up and organized practices are taking place. Organized teams are not supposed to play at the park. **Trustee Carelli** said the issue is that Hillsborough County Parks are still closed. In three months, this problem will go away.
- **Trustee Shidler:** The opening of the park went well, and we have not had too many people at the beach.

David O'Donnell — Scotty Cooper Park:

- **Trustee O'Donnell:** TECO was at SCP today working on changing over the electricity to our poles.
- **Trustee O'Donnell:** Has procured a number of quotes for fencing at Scotty Cooper Park. **The Trustee's** choice is West Florida Fence (current estimate: \$8,695.12). **The Trustee** suggests paying only: \$7,205.12, which can be accomplished by removing the entrance gate line-item from the price.
- **Trustee O'Donnell** made a motion to award the fence work at SCP to West Florida Fence in the amount of \$7,205.12; work to be completed in FY 2020-2010. (As advised by the Chair, the motion and budget DID NOT include installing a locking gate at Scotty Cooper Park.
- Motion Seconded by: Trustee Carelli
- Vote: 7 in favor; 2 opposed

• Sheila Santafemia: voiced her concern that the neighborhood has taken time to secure White Sands Beach and Original Carrollwood Park but has not taken steps to protect our most vulnerable — our children — at Scotty Cooper Park. Sheila has personally seen pedophiles, homeless people and others who don't belong in the park.

• **Trustee Price:** Will have signage proposals for the next board meeting.

Trustee Snellgrove introduced General Council Ken Tinkler:

- Ken Tinkler General Council: The Governor has begun Phase-1 of the opening process. Restaurants are opening with lower occupancy. At this point, Hillsborough County has opened wilderness parks only not public parks or skate parks or dog parks. The best way to learn about policy is to default to the Hillsborough County website. They have not given a timeline for opening the parks. Most likely, it will be next week two weeks after the Governor's original order. This will be dependent on CDC guidelines regarding social distancing.
- **Trustee Snellgrove asked the attorney to elaborate:** You are a special district designated by the Governor, and that distinction could be taken away. The County has the expertise in following the Governor's orders, and as an entity within the county, the special district should follow County guidelines.
- Jim Powell: I think it is prudent to follow Hillsborough County as long as cases don't spike.
- **Bryan Huls:** Will this change happen at the Governor's Thursday meeting? Ken Tinkler said that Hillsborough County has not made the step yet and neither has the state.
- Kevin Shidler: The Board must consider that there is no guard or security at Scotty Cooper Park (meaning, there is no one to address social distancing regulations). At Scotty Cooper Park, we are responsible for too many people gathering at the park, for example, ten people on the peer fishing. Council recommends posting the order from the state. **Trustee Shidler:** so moving forward, White Sands Beach could open at dawn as usual, when the order is changed.
- **Chrissie Price:** Are there specific rules about cleaning the bathrooms. Ken Tinkler advised that we don't know what those rules are yet. If there is a question, defer to the CDC website.
- Trustee Siddall: Will we open White Sands Beach? And will that put us in more liability?
- **Trustee Snellgrove:** There is confusion about White Sands beach.
- Ken Tinkler: The beaches that have opened outside of Hillsborough County are places where social distance requirements can easily be met. Your park (White Sands Beach) fits more into the description of a neighborhood park, not a beach.
- **Trustee Siddall:** The boat ramp is closing at 4:30 when it used to be opened later.

- **Trustee Shidler:** The problem is people are abusing the privilege, and we have to pay extra for the guard when people don't follow the rules.
- Trustee Siddall: Do we need another meeting if the Governor opens the parks?
- Ken Tinkler: I think, given the way you operate, your president can make that decision.
- Mark Snellgrove: I am in full agreement with that. In my view, if we have any issues, Ken has to defend our actions.

6. Regular Agenda

Suzan Giunta — Vice President & Grounds

- **Trustee Giunta:** Resident Brian Huls mentioned having work done at Duck Island to trim the trees and pull the weeks. **Trustee Giunta** asked if she could reach out to someone with a lawn service. There is a proposal from ASI on the agenda to clear the island on Samara, but the **Trustee** said she could probably get a better price. **Trustee Snellgrove** said that ASI is not responding to emails.
- There will be a three percent increase in the grounds maintenance budget. **Trustee Snellgrove**, asked what we are getting for our money?
- **Trustee Siddall** said, if they find something broken, they provide an estimate to fix it. **Trustee Giunta** said that we can probably cancel that part of the contract. ASI is charging \$780 to check our irrigation system, which includes all the zones. In regard to the grounds maintenance, there does not seem to be accountability. **Trustee O'Donnell** stated that if that what it costs to check sprinklers, we should open a sprinkler checking business.

Mark Georgiades — Treasurer Matters:

- **Trustee Georgiades:** I received from **Trustee Price** the estimated cost of \$35,000 for the refurbishing of the entry signs on Lake Carroll Way. I've also heard from **Trustee O'Donnell** in regard to budgeting Scotty Cooper Park. I request all Board members to send in their budgets.
- We received an invoice for an ice-machine purchased last summer. They tried to use our credit card. It did not work. It took them nine months to get back in touch with us. **Trustee Siddall** asked the cost of the ice-machine: \$1,900.
- Lucas Howes (a resident) joined the meeting at 7:03 p.m.

Mark Snellgrove – President Matters:

- Trustee Snellgrove:
 - A legal notice for the upcoming budget hearing was published in the Tampa Bay Times Newspaper on May 6, 2020
 - Question: Would the Board like to request an Off-Duty Deputy Sheriff for WSB on: May 25, (Memorial Day Weekend) and any other weekend thereafter?
 - **Personnel Matters** Janet Bourland started work today at 2:00 p.m. Prior to Laura Allegri, the hours were three hours per day, five days a week. Janet retired

from her previous job. We need to provide some financial security, so we have assigned the office hours of 2:00 p.m. – 6:00 p.m. **Trustee Siddall** asked if she could work until 6:30. **Trustee Snellgrove** said he would check on it. Moving forward, Laura and Shelley will only get paid when they are training Janet.

- **Shelley Stewart** recommended Janet Bourland's husband for the maintenance position.
- Trustee Giunta said he looks like a good candidate
- **Trustee Siddall** had recommended a person (numerous times) but the person has not been given an opportunity to interview for the position. **Trustee Snellgrove** asked if the gentleman was **Trustee Siddall's** neighbor. **Trustee Siddall** stated that he hardly knows the gentleman. He's just someone from the neighborhood. **Trustee Shidler** suggested that **Trustee Snellgrove** interview the gentleman and make a recommendation. **Trustee Costa** suggested that **Trustee Snellgrove** interview any qualified candidates and make a recommendation to the Board.
- **Shelley Stewart** has done a phenomenal job; she loves helping the community. If you see her, thank her.
- **The Trustee** has requested the restrooms be cleaned once per week.
- **Room rental request:** The Anderson family would like to rent the Rec Center for a few hours. Their fishing club would pay for it. **Trustee Snellgrove** asked for comments: **Trustee Costa** asked if they would pay the standard \$400 deposit. Michael Carelli — Original Carrollwood Park: Not Present.

• Trustee Carelli: No new business.

Kevin Shidler — White Sands Beach:

• **Trustee Shidler:** We should follow the guidance of Council.

David O'Donnell — Scotty Cooper Park:

• **Trustee O'Donnell: The Trustee** is awaiting quotes for securing SCP. **Trustee Costa** said that as duly elected officials, the Board should simply make the decision to either

secure or not secure the park and to not canvas the entire neighborhood for opinions. **Trustee O'Donnell** agreed, as did **Trustee Shidler**. **Trustee O'Donnell** added that he would likely have a budget for securing the park next month. **The Trustee** was not happy with the initial details of the bids and has asked that they all be redone.

The Trustee would like to contract for this as a turnkey, design-build, if the rules allow, as the vendor has received zoning approval and provided the designs. The scope does not include replacement of the landscaping or up-lighting as needed. The requested budget for this project is \$35,000.

- **Trustee Snellgrove** reopened Public Comment at 8:27 p.m. There were no comments.
