- **Resident Shelley Stewart:** Questioned if a decision has been made to not allow Moon Drop Yoga to use the small room at the Rec Center. **Trustee Snellgrove** said it was not on the agenda.
- Resident Andrea Griffie: no comment
- **Resident Dr. Anna Brown:** Asked about expected timelines for landscaping, the signage at the entrance to Original Carrollwood on Lake Carroll Way, and work to be done at Scotty Cooper Park. Dr. Brown also suggested that the Board work on projections for future projects.

#### 6. Regular Agenda

#### Mark Georgiades — Treasurer Matters:

• **Trustee Georgiades:** noted that the Board budget is at the limit regarding lawn maintenance.

#### Mark Snellgrove – President Matters:

- Trustee Snellgrove: To answer Dr. Brown's inquiry about projections, the Trustee noted that the Board has been consulting our attorney about raising the taxes, but that it must be brought to a vote by the community. Trustee Carelli explained that the Board would share projections and plans with the community and explain why, with the cost of inflation, we must increase taxes to better serve the neighborhood. He also noted that just because a proposed increase is approved, it does not mean that the entire increase would be implemented immediately. We know that the budget we have today based on taxes received will not serve the neighborhood five or six years from now. Trustee Shidler, said that it's hard for me to think about new parks or playground equipment before we know the kinds of funds we will have coming in.
- Shirley Pearsall, resident and landscape architect, presented to the Board and residents in attendance drawings of landscaping for the signage at the entrance of Original Carrollwood at Lake Carroll Way. Shirley made a 15-minute presentation and fielded questions from the Board as well as from residents. Shirley and resident Ryan Horstman discussed the choice of native plants versus plants not native to Florida. Ryan suggested not using plants that are hard to maintain and that attack weeds. Trustee Siddall suggested completing the landscaping before adding lights and noted that the Board should not skimp on lighting. Trustee Snellgrove said that Shirley would move forward with bids and work with Janet in the front office.

#### Michael Carelli — Original Carrollwood Park:

• Trustee Carelli explained to Dr. Clapp that, yes, a goof was made at the parks in regard to keying. The changes were made for security reasons. The Trustee further explained that sports teams from outside the neighborhood have been playing at the park without approval or permission. The Trustee also noted that kids have been jumping

the fence, which is why the locks were double keyed. **The Board** does not want people or dogs in the park that are not residents. The "goof" was made by the locksmith that did not complete the work. **Trustee Giunta** will meet with the locksmith and will inform Dr. Clapp when the locks have been fixed.

- Trustee Carelli shared with the Board bids for the tennis court lights. The Trustee ensured that the bidders were using similar specs. The lowest bid was from Synergy Electric, a company that the Trustee likes. The Trustee would like to move forward with this company.
- Motion by Trustee Carelli to award a contract to Synergy Electric to make the improvements on the tennis court lights for a cost of: \$6,444.99.
- Motion Seconded by Trustee Siddall
- Vote: 9 in favor; 0 opposed
- Trustee Carelli spoke to the Board attorney about potentially moving forward with a tax increase. The Board must come up with a hard number cap that can be implemented incrementally over a course of years. The Trustee noted that if the neighborhood could not properly maintain the lake and the parks, the county could potentially take control of the properties.

#### **Kevin Shidler — White Sands Beach:**

- Lake Test Results were very high on the south side.
- Dr. Patel called the **Trustee** to say that he is seeing activity at the lake after hours, but that it is coming from the lake side. Dr. Patel proposed using a security laser to monitor the lake. **Trustee Snellgrove** said that the **Trustee** should move forward with estimates.

#### Jack Griffie — Scotty Cooper Park:

- Trustee Griffie: The fence company will install at Scotty Cooper Park on the following dates: 7/12 to 7/15. The Trustee would like to move forward with shrubbery removal at SCP. NOTE: SCOTTY COOPER PARK WILL BE CLOSED FOR THIS ENTIRE WEEK.
- Motion by Trustee Griffie to award a contract to ASI Landscape Management in the amount of \$3,989.25 for the removal of an existing hedge.
- Motion Seconded by Trustee Price
- Vote: 9 in favor; 0 opposed
- The Trustee obtained an estimate to trim dead branches at SCP. Trustee Georgiades said there was nothing left in the SCP budget for additional tree trimming. Trustee Costa stated that falling tree branches are a serious hazard to visitors and must be addressed. The Board discussed moving money from the Rec Center budget to SCP.

<u>Motion</u> by **Trustee Griffie** to award a contract to Tri-County Tree & Landscaping in the amount of \$3,950.00 for the trimming of dead tree branches at Scotty Cooper Park.

#### Suzan Giunta - Grounds:

- Trustee Giunta: Reviewed with the Board Tennis Court Light Proposals.
- Motion by Trustee Giunta to Award Florida State Fence a contract in the amount of \$20,555.61 for new fencing at Scotty Cooper Park.
- Motion seconded by Trustee
- **Vote:** 9 in favor; 0 opposed
- **The Trustee** mentioned having irrigation inspections again. **Trustee** Georgiades said no, it wasn't in the budget.

#### Paul Siddall — Recreation Center & Tennis:

• Trustee Siddal said that we have been using Band-Aids to fix and upkeep the community. The Trustee noted that the Board should get the budget and proposed increases in order before we start considering new projects.

**Shelley Stewart** noted that Stacy Fender, who runs Moon Drop yoga, would like to use the small room at the Rec Center for her yoga class. **Trustee Carelli** stated that he fully supported Stacy when she ran the yoga classes on a volunteer basis but having spoken to Janet and being told that it is a for-profit business by a non-resident, he would not be in support of allowing Stacy to use the Rec Center. **Trustee Shidler** said that Shelly, as a resident, could rent the room and yoga could take place there.

**Trustee Siddal:** Questioned whether the Board thought that the Rec Center needed to be re-painted. **The Trustee** also noted that the Board is purchasing a wet-vac.

#### Chrissie Price — Community Development:

- Trustee Price: presented photos of neighborhood signage, specifically the posted rules. Trustee Snellgrove stated that Trustee Price should check with Janet on the wording, using Trustee Carelli's signs as a model.
- **The Trustee** asked if the Board would like to see an RFP for all the signs. The Board agreed that the signage should be uniform.
  - The main entrance signs should be up within the next two weeks.

**Trustee Siddall** asked that signage on the gates at WSB, SCP, and OCP be reflective.

#### 6. Regular Agenda

#### Mark Georgiades — Treasurer Matters:

- **Trustee Giunta:** reviewed long-term tennis court maintenance cost for future budget planning purposes
- **Treasurer Georgiades:** presented the "draft" budget for FY 2021-2022, while soliciting input from committee chairs on final adjustments
- Treasurer Georgiades: discussed long-term planning from public comment
- Treasurer Georgiades: Public Hearing scheduled for June 14, 2021

#### Mark Snellgrove – President Matters:

- **Trustee Snellgrove:** read aloud the General Counsel's detailed Checklist for Increasing the District's Assessment.
- **Trustee Snellgrove:** asked if the Board would like to request Off-Duty Deputies for WSB on May 24, (Memorial Day Weekend).
- Trustee Shidler: indicated yes. Since it has been difficult to get Off-Duty from the Sheriff's office this year, Trustee Shidler indicated that we should consider using Florida Fish & Wildlife Off-Duty Law Enforcement Officer's.

#### Michael Carelli — Original Carrollwood Park:

- Trustee Carelli: invited Locksmith Wes Robinson from Action Lock & Key to discuss Access Control. Wes did a detailed presentation to the Board, with Board members asking questions. There would be issues with a key fob if the power is out, and if the key fob doesn't allow access. It appeared the CRD would need someone to be on-call all the time. It seems key access is less complicated and less expensive.
- Trustee Carelli: discussed a recent incident at OCP where he observed a group of nine teenagers playing flag football (believed to be in their 20's) hop the fence to gain access. They then placed a stick in the gate to keep it open. The Trustee determined

they were not residents and were trespassing so he asked them to leave, but they refused very disrespectfully, so **Trustee Carelli** called the Sheriff's office and a deputy responded and the deputy enforced the trespass.

- Trustee Carelli: presented a quote to the Board from Palma Ceia Lock & Key, Inc. for gate access improvements at Original Carrollwood Park. The cost is \$2,317.00, an amount that requires Board approval.
- Motion by Trustee Carelli to Award Palma Ceia Lock & Key, Inc. a contract in the amount of \$2,317.00 for gate access improvements at Original Carrollwood Park.
- Motion seconded by Trustee Siddall
- Vote: 8 in favor; 0 opposed
- **Trustee Carelli:** addressed resident Kristy Taylor's question from public comment regarding new playground equipment. There is not enough money at this time, in order to move forward with this project, the Board would need to raise the taxes.

#### **Kevin Shidler — White Sands Beach:**

- **Trustee Shidler:** reported recent graffiti at WSB. It happened three nights in a row, skipped a night, then happened again. So 4-nights total. The Sheriff's office in investigating.
- Trustee Shidler: looking into a camera system.
- Trustee Siddall: recommended gaming cameras.
- Trustee Siddall: the vandals know that cameras are out there and will cover their faces.

#### **Jack Griffie — Scotty Cooper Park:**

- Trustee Griffie: reported that before the contract could be signed for Florida State Fence after the April meeting, material cost increased by \$570.86, so the Trustee presented all bids again to the Board.
- Motion by Trustee Griffie to Award Florida State Fence a contract in the amount of \$21,126.47 for new fencing at Scotty Cooper Park.
- Motion seconded by Trustee Giunta
- Vote: 8 in favor; 0 opposed
- Trustee Griffie: presented playground mulch proposals to the Board.
- **Treasurer Georgiades:** lets hold off until we know the cost for other work that first needs to be completed, since the mulch would be the very last item anyway.
- **Trustee Griffie:** it will take at least 4-weeks before the fencing contractor can begin work, so that is fine.
- Trustee Snellgrove: This provides time to solicit additional quotes for comparison.

#### Suzan Giunta - Grounds:

- **Trustee Giunta:** indicated that she has a conflict of interest for the main entrance landscape proposals on the meeting agenda, so the Trustee left the meeting room and was-not present for this discussion.
- Trustee Snellgrove: led the discussion as Chair and because there was no consistency in the three bids, the Board requested that we seek the advice & guidance of resident Shirley Pearsall, who is a retired professional landscape architect. Shirley advised the Board with the 2019 Lake Carroll Way median project.

#### Paul Siddall — Recreation Center & Tennis:

- **Trustee Siddall:** believes that resurfacing the tennis courts every 5-years is too frequent.
- Trustee Giunta: based on tennis court deterioration, we should budget every 5-7 years.
- Trustee Siddall: will be evaluating the tennis court pavilion and bridge.
- Trustee Siddall & Trustee Giunta: have issues with Carrollwood Elementary School parents using the Recreation Center parking lot for daily drop off and pickup. The Board consensus was because it is so close to the end of school, to wait and reconsider the issue with the beginning of the fall school year.

#### **Chrissie Price** — Community Development:

• Trustee Price: the community sign completion is still 4-weeks out.
