#### Resolution 2022-1

A Resolution of the Board of Trustees of the Carrollwood Recreation District

Resolved by the Board of Trustees ("Board") of the Carrollwood Recreation District ("District"):

**WHEREAS,** the Board finds that the current amount of revenue generated by the Carrollwood Recreation District Tax is insufficient to address and maintain required and existing improvements to District property; and

**WHEREAS,** to fund the financial needs of the District, the Board finds that it is necessary to increase the maximum amount of the Carrollwood Recreation District Tax that may be assessed each year to pay for current and additional new improvements to District property and maintenance of such improvements; and

**WHEREAS**, for these reasons, the Board approves placing a referendum on the August 23, 2022 ballot proposing to change the maximum annual assessment of the Carrollwood Recreation District Tax that may be considered each year by the Board when the annual budget is developed.

#### Now, therefore the District resolves as follows:

- 1. The District directs the Hillsborough County Supervisor of Elections to place on the August 23, 2022 ballot a referendum regarding a change to the maximum annual assessment of the Carrollwood Recreation District Tax from \$600 to \$1,200, assessed against each improved residential parcel, both homes and townhomes, as specified in Exhibit A.
- 2. The Supervisor of Elections shall fix the cost of holding the referendum at an amount to be approved by the District, and the District shall pay that amount to the Supervisor of Elections.
- 3. The District shall publish notice of the referendum in a newspaper of general circulation at least twice in the 30 days immediately preceding the referendum.
- 4. The Supervisor of Elections is authorized and directed to canvas the returns on behalf of the District and to announce the results upon completion of same.

### Changing the Carrollwood Recreation District Tax Maximum Annual Assessment

#### **BALLOT SUMMARY**

Should the maximum annual amount of the Carrollwood Recreation District Tax, a non-ad valorem annual assessment imposed on each individual improved residential parcel located within the boundaries of the Carrollwood Recreation District, be changed from the current maximum of \$600 per year to a revised maximum of \$1,200 per year?

History: With a vision and foresight, upon completion of the Carrollwood Subdivision ( now commonly referred to as The Original Carrollwood Community ), the CRD was created by a special act of the Florida Legislature on April 20, 1972, and approved by a community vote ( a referendum ) on December 5, 1972, to manage, operate, and maintain the Community's common areas. The CRD is ranked the 197th oldest of the 321 special districts created by the legislature. Today, special taxing districts are created by the County. The first CRD assessment was in 1973 in the amount of \$50 on the property tax bill, which doubled less than two years later. From that point, the historical average has been to double the TAX CAP every 20-years to keep up with inflation. The last time the tax CAP doubled was from \$300 to \$600 20-years ago. The increase back then was over a period of 8-years to reach the \$600.00 CAP that it is @ today.

This is a non-ad valorem assessment on everyone's property tax bill that lives within the subdivision boundaries and has existed since 1973. When each homeowner pays their taxes every year to the Hillsborough County Tax Collector, the CRD's non-ad valorem portion comes back ( not the full amount ) to the board so that the board can manage and operate the Recreation Center, the Tennis Courts, White Sands Beach, Original Carrollwood Park – the dog park, 2-dozen common areas, Scotty Cooper Park, pay the TECO bill for 2-dozen meters, pay the water bill for 2-dozen meters, pay for maintenance repairs for all the above properties & common areas, pay the liability insurance, pay the employees, trim the trees, cut the grass, and clean the toilets.

The Original Carrollwood community infrastructure is 63-years old. The 9-board members are all non-compensated property owners, who pay to serve on the board. It is with this fiduciary responsibility that this recommendation is being made.

## Background


By 1959, Carrollwood Subdivision (now commonly referred to as The Original Carrollwood Community) had become one of the foremost award-winning "subdivisions" in the area and boasted of amenities unheard of at the time, including air-conditioned housing, a planned school, neighborhood parks, lake access for all residents, and on-call handyman and repair services. The winding roads, cul-de-sacs, and lake views added even more charm to the young community.

1959 – First homes sold in what is now known as Original Carrollwood.

1961 – Original Carrollwood named U.S. Subdivision of the Year by the National Association of Home Builders.

1962 – Original Carrollwood receives Best Homes for Families with Children Award from Parents magazine.

1972 – Special taxing district created for Original Carrollwood to support community amenities such as parks, the recreation center, and White Sands Beach.

Increase the non-ad valorem tax maximum to \$ 1,200 per year for each improved residential parcel within the district in a uniform amount. The board does not anticipate increasing taxes by the entire amount immediately but staggered over a period of years. Though it is impossible to anticipate exactly what the cost of continued maintenance will be, the increase in the tax cap is anticipated to be sufficient to address required maintenance improvements needed at this time. The current assessed tax of \$600 is insufficient to maintain the district's 63-year old infrastructure.

#### Resolution 2022-1

A Resolution of the Board of Trustees of the Carrollwood Recreation District

Resolved by the Board of Trustees ("Board") of the Carrollwood Recreation District ("District"):

**WHEREAS**, the Board finds that the current amount of revenue generated by the Carrollwood Recreation District Tax is insufficient to address and maintain required and existing improvements to District property; and

**WHEREAS**, to fund the financial needs of the District, the Board finds that it is necessary to increase the maximum amount of the Carrollwood Recreation District Tax that may be assessed each year to pay for current and additional new improvements to District property and maintenance of such improvements; and

**WHEREAS**, for these reasons, the Board approves placing a referendum on the August 23, 2022 ballot proposing to change the maximum annual assessment of the Carrollwood Recreation District Tax that may be considered each year by the Board when the annual budget is developed.

#### Now, therefore the District resolves as follows:

- The District directs the Hillsborough County Supervisor of Elections to place on the August 23, 2022 ballot a referendum regarding a change to the maximum annual assessment of the Carrollwood Recreation District Tax from \$600 to \$1,200, assessed against each improved residential parcel, both homes and townhomes, as specified in Exhibit A.
- The Supervisor of Elections shall fix the cost of holding the referendum at an amount to be approved by the District, and the District shall pay that amount to the Supervisor of Elections.
- The District shall publish notice of the referendum in a newspaper of general circulation at least twice in the 30 days immediately preceding the referendum.
- The Supervisor of Elections is authorized and directed to canvas the returns on behalf of the District and to announce the results upon completion of same.
