- Reserve fund account: current balance \$397,317.16 and adding \$50,000 soon.

### President Snellgrove

- Board discussed access control updates for restrooms.
  - The Board will hold off on moving forward until Original Carrollwood Park fence and FOB access is complete. The preliminary quotes received were high and the board will revisit the topic and decide best options for all bathroom locations.

#### Recreation Center/ Tennis Chair Dr. Anna Brown

- FOBs are working great. There's been an issue with propping the gate and the situation will be addressed as needed.

#### Original Carrollwood Park Chair Lavisky

- Board discussed new fence design options.
  - Received preliminary quotes and other options will be revisited.
  - At December's meeting, a few residents asked about adding parking spots near the dog entrance gate and moving the fence.
    - Board discussed the pros and cons: the number of parking spaces, consider any ADA regulations, permitting costs and property ownership complications.
    - Board discussed moving the dog park gate entrance to the main park gate, accessing the main entrance bridge. Closer parking at the Rec Center. A new walkway fence on the left side of the park.

#### White Sands Beach Chair Shidler

- Lab results from the swim side have been higher since the lake levels are low.
- Marc Cohen: received a letter to come to a meeting to discuss the deactivation of his FOB at White Sands Beach. There was an anonymous report that Marc drove his vehicle onto the beach. Marc explained that he drove his truck onto the beach to take family pictures and didn't know it wasn't allowed and will not drive on the beach again. The board thanked him for explaining the situation and his FOB will be reactivated immediately.
- Resident Julia Serynek, who is an independent Storm Water Engineer, came to discuss the lake levels that have been a concern for many residents. She will attend the CCA meeting but gave the CRD a quick update on her independent findings. She pulled Tampa Bay Water permitting and what they are allowed to do and plans on reaching out to Tampa Bay Water to discuss the problems.

#### Scotty Cooper Park Chair Griffie

- There is still an outstanding issue with the new gate that needs to be fixed.

- Researching quotes with companies. A new sign was put down by White Sands Beach.
