- **Trustee Maas** presented highlights from the 2017 FYE Budget. The debt services for 2016 was \$190,941. The debt service for 2017 is currently \$194,000. After discussion by the Board in regard to the accuracy of the debt service numbers, it was agreed that the budget could be adjusted later.
- **Trustee Maas** suggested that \$4,000 may be moved from debt service to grounds, given the amount of tree trimming that has been required. **Trustee Lais,** agreed it would be useful.

# Hear from the Public

- **Trustee Jaap** discussed the cash projections for 2017 FYE. As of June 13, 2016 the low cash projection was \$238,461, down from \$313,015 the previous year. The **Trustee** says this is only a concern if it drops again next year. So this will be something to watch. During the next five years, the **Board** should be cognizant of how money is spent in regard to improvements until the debt is paid off.
- **Resident Shelley Stewart:** Suggest planting trees or bushes in OCP on the back side of the dog part near GFS and Red Lobster as a sound barrier. She also gave kudos to the guard at the beach who helped her with her new Kayak.

- Board vote to Adopt the 2017 FYE Budget based on the district tax rate of \$600.00 to be assessed and collected upon the taxable property of the district for 2017 – FYE.
