6. PUBLIC COMMENT ON THE BUDGET

- **Bennet Jacobson** asked about the proposed increase of \$600 and in what increments the additional funds would be raised. **Trustee Carelli** stated that the Board will go to \$800 immediately, however, he could not say how long it would stay there. Mr. Jacobson did not see that number printed anywhere. **Trustee Brown** stated that the number was in the Caroler.
- Tom Korun of Reclinata Lane asked if the Board knew where he was located. He is located at the dead-end of Reclinata Lane on White Trout. Mr. Korun questioned whether his home was located in Original Carrollwood or not. According to Trustee Snellgrove, Mr. Korun is indeed in Original Carrollwood. Mr. Korun asked if the Board services White Trout lake. The Trustee explained that lake care is the duty of the CCA Board.
- **Rebecca Williams** queried about the broken batting cage at Original Carrollwood park repaired.
- Abby Huls posed a question: If the neighborhood does not pass the increase, is there a
 possibility that the neighborhood parks could get taken over by the county? Trustee Carelli
 explained. Abby asked if this had happened before? Trustee Snellgrove said yes, and he
 explained that the Governor recently eliminated six special taxing districts.
- A Resident On Lake Ridge: asked about the direct mail sent to the neighborhood. He said that it looked like junk mail and was thrown away.
- **Bryan Huls** wanted to know, if we go door to door, is there a way to have materials to hand out?

- **Abby Huls** did not realize how impactful this (tax) issue could be if the referendum is not approved. She believes that many others may not understand its importance.
- Larry (Resident) questioned the purpose of accumulated funds, community development, and community improvement line items as listed in the Proposed Annual Budget. Trustee
 Shidler explained, as an example, the cost of the guard service. Trustee Georgiades, explained community development
- Adrian (Resident) would like talking-points to explain to her neighbors. She would like postcards with simple talking points.
- Nicole Barolo: The posts on Original Carrollwood Facebook are not sharable (sic).
- Trustee Brown: explained the Myth & Facts section of the Caroler which came out last month.
- Abby Huls does not read the Caroler but has used it to wrap fish now and again.
- **Kristen (resident)** questions whether the neighborhood has ever had a fund-raising campaign for the parks and perhaps for new equipment. **Trustee Carelli** explained that it has been proposed, however, not implemented.
- Tom Korun –suggested setting up an email system for everyone in the HOA (sic).
- **Josh (Resident)** questioned the increase and how the increases would take place. **Trustee Carelli** explained.
- Matt Leviski a new resident, asked about the increase and whether millage rates could be used to calculate the increase. **Trustee Carelli** explained, no, as per the attorney.

4. Public Comment Opened:

- Shelley Stewart: is in support of the Assessment adjustment. She was on vacation during the public hearing but is in support. She also asked us to help with the County funds for sidewalks. She said they came from COVID relief funds. She asks the CRD Board to ask for some of these funds to be spent in our neighborhood. Finally, she is in favor of providing Janet and Gary with a raise in hopes to eventually get them both up to \$18/hr. She is very happy with their working team and the results they get for us as a community. Please treat these good employees well and reward them and they should have an equivalent paygrade as they support each other in many ways.
- **Dr. Rick Dillon** said the public meeting was well run and he thought it was a good job.
- John Schinka (treasurer for CCA) thank you for all the work done for the public hearing. He learned much and was appreciative of the information shared. He shared that the costs for CCA events have also increased drastically. Everything is doubling in price. CCA may need an increase in the rental income from the CRD in order to maintain the level of community events needed.
- Rick Lopez is to be credited for recommending the signs announcing CRD meetings.
- Lawrence Davis: He has lived here since 1971 and this is his first meeting. He is very disappointed in the president and treasurer...he sent emails and did not get a response. He came down and spoke to Janet in the office. He finally received a response from the president

with two PDF documents that did not answer his questions completely. He would like any rental of the OC park to turn out like the I-9 rental time as it was too crowded and made the area inaccessible to residents. Would like to see one key for everything. Biggest concerns are the condition of the sidewalks.

- Rachel Marshall uses Scotty Cooper Park daily. She would like to see some improvements
 there. The metal ladder has snapped and caution tape is in place. Some of the steps are in
 need of repair. Rubberized mulch would be helpful. Please consider major improvements
 there.
- **Neil Norden** felt that the communication was well done. Appreciates all of the communication up to the public hearing.

Mark Georgiades — Treasurer Matters:

- Discussed the line item for CCA. CCA liaison was present to make a request for \$40,000.00
- **Treasurer Georgiades** also reported increases for insurance, white sands beach repair, scotty cooper park, maintenance issues with walls, grounds, etc.
- Public Hearing on FYE-2023 budget next month.

Mark Snellgrove – President Matters:

- Mark received a letter that the accountant is increasing fee from \$450 to \$950/ mo. Mark went out to five CPAs for quotes. He is recommending Blake and Moore, CPAs, PA. They estimate \$500-550/mo. If the Board agrees, he will send us an engagement letter. There is no specified term but is understood to be a yearly term.
- Motion by Trustee Georgiades that effective June 1 the bookkeepers be changed to Blake and

Moore

- Motion Seconded by Trustee Shidler
- Vote: 6 in favor; 0 opposed
- Mark recommended to increase the number of hours for Page Four Creative to 55-hours/month. This will be an increase of \$4125.00. The agreement will be evaluated monthly.
- Motion by Trustee Price
- Motion Seconded by Trustee Georgiades
- Vote: 6 in favor; 0 opposed
- Janet and Gary have performance reviews due. Both are making \$15/hr. Both work 15-20 hrs/wk. Mark recommends a 10% increase (\$16.50/hr)
- Motion by **Trustee Brown** to increase pay to \$17 and to set a periodic review cycle that is separate from pay increases.
- Motion Seconded by Trustee Shidler
- Vote: 6 in favor; 0 opposed
- Mark Snellgrove spoke to answer the concerns of Mr. Davis. He stated that as president, he did in fact return the email. He provided the expense codes and what they were for. They need to be added up to see how the money is spent. The social events in the community are not paid by the CRD. The CCA budgets for and manages all social events. The CRD does have a lease agreement with the CCA. For the current year, the lease/rental fee paid to the CCA was \$28,000.00. In reference to the phone bill, the cost of \$3000/year is due to three incoming lines and one of which is monitored for fire and emergency services.
- Mark Snellgrove reported that six special taxing districts were dissolved in April. He stated that a NO vote on the assessment could put us closer to being dissolved. We need to increase the amount we have in savings for reserve.
- We will a have public hearing regarding the proposed budget on June 13th. It has been publicly noticed in the newspaper and will be placed in the caroler.
- We need a PR person for social media purposes and help us stay within the guidelines of the sunshine law. If we become insolvent, we could get dissolved and all properties be transferred to the county. He encourages Nicole to make a difference for us.

Michael Carelli — Original Carrollwood Park:

- Trustee Snellgrove presented this item for Carelli. The students at Corbett Prep will be participating in summer camp and using OC Park. They are requesting use of the field and park for \$500 per week for three weeks. 8-12 and 1-4. TRUSTEE Shidler mentioned that we should be consistent with our rental fees and charge the same amount for the school that we charge for sports use.
- Motion by **Trustee Brown** to authorize Trustee Carelli to negotiate a fair market value for rental and contract with Corbett Prep for use of OC Park for their summer camp dates.
