## Treasurer Georgiades

- Committee Chairs need to submit their requested budgets as soon as possible.
- A draft budget will be provided at the May 13th board meeting.
- It is essential that we have a board quorum at the June 10<sup>th</sup> public hearing to adopt the FY 2024-2025 budget.
- Treasurer Georgiades doesn't foresee any need to raise taxes. The FY 2024-2025 budget will be based on an \$800 tax assessment per OC home.
- President Snellgrove reported that the roof repairs have been completed.
- Trustee Dr. Brown requested that a long-term plan be discussed on future projects. We need to look at other building and maintenance needs for the other properties, so we stay ahead of the needs and plan for future expenses. Also, long-term planning for trees and landscaping.

## **President Snellgrove**

- Upon the recommendation of Trustee Lavisky, the umbrella policy limits are being reviewed.
- Trustee Lavisky is researching tort immunity and property attachment.
- Trustee Lavisky attended the March & April CCA meeting to address his concerns. The concern is that three of the four community properties are owned by the CCA board.
- Both the CRD & CCA are named insured on the same general liability policy.
- Trustee Lavisky is waiting for the CCA Board to consult with their general counsel.
- There are concerns that the current umbrella limits are insufficient.
- The current umbrella policy might have to be canceled and a new umbrella policy written.

• Trustee Dr. Brown will work with Trustee Lavisky on other maintenance needs on properties and plan for long-term future work.
