#### 6. Regular Agenda Ryan Maas — Treasurer Matters

- **Trustee Maas:** In the final month of the fiscal year, projections indicate that we will go over budget. The **Trustee** has asked that the **Board** amend the budget to preempt the going over budget.
- Motion from **Trustee Maas** to amend the 2017-18 fiscal year budget and increase the use of accumulated funds by \$20,000 to \$52,702 for an increased annual budget of \$621,302. **Further,** of the \$20,000, \$14,000 will be allocated toward our principal debt service, \$2,000 toward our interest debt service and \$4,000 to be allocated toward guard service at White Sands Beach.
- Seconded by Trustee Carelli
- Vote: 9 in favor, 0 against

#### Mark Snellgrove — President's Agenda

- **Trustee Snellgrove:** For the October Caroler, the Trustee asked that **Trustee Shidler** place an article reminding residents about boat decals.
- **Trustee Snellgrove:** We are done with off duty law enforcement.
- **Trustee Snellgrove:** discussed the prices for renting the Rec Center. Current rates are \$350 for the large room with dance floor; \$225 without the dance floor. When there are multiple events, John Probst inspects the room in between events. John charges \$75 to inspect, if the inspection occurs outside of his normal working hours. The Board agreed to raising the rates for each room to reflect the increased cost of maintenance. Thus, new bookings for the large room with the dance floor will rent for \$425; and without the dance floor for \$275. The smaller room which rented for \$125, will now rent for \$150. (A 6.8% sales tax is added to each of the room rates).

#### Vice President Suzy Giunta — Tennis & Recreation Center Chair

• **Trustee Giunta:** Not in attendance.

#### Michael Carelli — Original Carrollwood Park

• Trustee Carelli: The Trustee had the bridge to OCP pressure washed. It looks great.

- Trustee Carelli: The Trustee asked former CRD Member Bill Lais (in attendance) to discuss the existing agreement for Grounds. Bill created all vendor agreements for the CRD and has volunteered his time to help out with the project. Trustee Siddall explained some of the issues the neighborhood has been having with Green View. Bill presented Trustee Carelli with a CD containing contracts and bidding documents.
- **Trustee O'Donnell:** shared with the Board, that at 2:30 a.m. on Thursday of the previous week, water from the sprinklers at SCP flooded his street.
- **Trustee Carelli: The Trustee** queried the Board in regard to any other grounds issues that should perhaps be addressed in the new agreement.
- **Trustee O'Donnell:** The floating weeds often pile-up at SCP. **Trustee Siddall** explained that the weed issue is affected by the prevailing winds.
- Trustee Shidler: WSB irrigation needs constant work.
- **Bill Lais:** Asked about John Probst raking weeds at WSB. **Trustee Carelli** suggested that we leave John that job.
- Trustee Costa: No issues.Trustee Rasemont: No issues
- **Trustee Carelli: The Trustee** posed a question to the Board. Do we want to let Green View know that we are putting the Grounds account up for bid? We must let Green View know in writing if we are not going to renew the contract by January 31<sup>st</sup> 2019.

#### 6. Regular Agenda

#### **Ryan Maas** — Treasurer Matters

• **Trustee Maas:** The budget remains tight, even with Tamko funds having been deposited. **Trustee Mass** asked all **Trustees** for a list of their monthly expenses.

• Trustee O'Donnell has \$4,000 to spend at Scotty Cooper Park (which Trustee Maas has accounted for). Trustee Maas asked Trustee Shidler when the guard service will taper offer. The Trustee replied, September. Trustee Carelli has hired a service to pressure wash and seal the wood planks on the bridge at OCP. Grit will be added to the seal-ant to make it non-slip. Trustee Siddall said that he will still need \$5,000 for the month for the grounds budget—an amount already taken in to account.

#### Mark Snellgrove — President's Agenda

- **Trustee Snellgrove:** West Florida Fence quoted \$2,179.00 for a V-Track fence at WSB for the boat trailer ramp. **Trustee Siddall** asked how they are going to attach the V-Track to the ground. **The Trustee** added that he doesn't think that the current concrete will have the integrity. **Trustee Siddall** proposed that **Trustee Snellgrove** check into getting a higher quality wheel, perhaps a pneumatic wheel or one with sealed barriers, and to ask about the integrity of the concrete.
- **Trustee Snellgrove:** Florida Fish and Wildlife worked August 5<sup>th</sup> and is scheduled for September 2<sup>nd</sup>. **The Trustee** asked if anyone wanted to add another date. No one did.
- **Trustee Snellgrove:** It has been challenging this year to meet quorum. So, the **Trustee** asked that we all try to attend meeting regularly.

#### **Vice President Suzy Giunta — Tennis & Recreation Center Chair**

- Trustee Giunta: The Trustee recalled a discussion from the July board meeting regarding improvements to lighting, sidewalks and streets in Original Carrollwood. The Trustee called the County to meet and discuss. Trustee Snellgrove said that such a meeting should include the CCA Board, at a Saturday district committee meeting.
- **Resident Stacy Fender:** Ms. Fender has a girl scout troop that meets at the Rec Center. They meet at 1:15 p.m. on Monday afternoons. She would like to push the meeting to the fourth Monday of each month from 3:00 p.m. to 5:00 p.m. **Trustee Giunta** said that there may be a conflict on certain days, and that Ms. Fender should check with the Rec office for scheduling.

#### Michael Carelli — Original Carrollwood Park

- **Trustee Carelli**: **The Trustee** surveyed OCP and saw that there were a few ant hills, but not many. **Trustee Siddall** would check with our grounds keepers about spraying.
- Trustee Carelli: The Trustee met with AmeriScape (an irrigation company) to review ongoing irrigation issues. AmeriScape looked at the Rain Bird boxes and noticed that one box was drawing twice the power as the other. There were a couple of problems discovered. Island #20 was originally two zones. Two valves were wired together trying to create one zone—and neither worked properly. Now, wired separately, both zones turn on at separate times with full pressure. Also, the Hunter nodes were broken on three

zones. They have been replaced. Another underlying issue was that the sprinklers were set to come on at 2:00 a.m., but the pump was not, therefore, there was no pressure. Other work was completed and now the irrigation works as it should. Total Cost: \$560.00.

• Trustee Carelli: The Trustee suggested that when the grounds contract is up, we should put it up for bid. Trustee Siddall asked if we should have separate irrigation contract. The answer: It depends. The neighborhood's former grounds vender, Davey, for example, is a full-service provider with irrigation and insect control components. Our current grounds vender, Greenview, is not. Trustee Carelli said he will assist Trustee Siddall with the RFP process.

#### **Kevin Shidler** — White Sands Beach Chair:

• Trustee Shidler: Nothing to report.

#### David O'Donnell — Scotty Cooper Park

• In September 2016, **The Trustee** acquired three bids for landscaping at SCP. Now, unhappy with the chosen company, he queried the Board whether new bids were required. He also isn't sure that the companies will honor two-year-old bids. **The Board** suggested getting new bids. Note: (If a project is under \$4,000 the **Trustee** need only get one bid. If the project is over \$4,000, then three bids must be solicited.)

#### **Other Business**

- **Trustee Carelli:** Asked if **Trustee Rasemont** wanted to work on the landscaping at the entrance to the neighborhood on Lake Carroll Way. She said she would. However, **Trustee Siddall** is already working on the project.
